OYC does not warrant the condition of any portion of the marina and/or the floats, gangways, ramps or mooring gear. OYC makes no representations with respect to the amount of power available to the Vessel Owner and/or the condition of the electrical fixtures.

OYC shall not be responsible for injuries to persons, including Vessel Owner and/or Vessel Owners guests, agents or employees, nor for damage to property belonging to Owner and his/her guests, agents or employees for any reason whatsoever. Vessel Owner agrees to hold OYC harmless and indemnify it against all loss, damage, liability or expense of any kind and/or nature, including but not limited to, attorney's fees resulting from Vessel Owners acts or failure to act or those of his/her agents, employees or guests in use of the vessel, the premises of adjacent waters or areas. Vessel Owner waives all claims against OYC and agrees to hold OYC harmless for any injury to anyone, including but not limited to, owner and/or his guests rising from the physical condition of the berth, the land and or water approaches thereto or exits.
